#### **Small City Block Grant Program**

**Harmony:** Submitted pre-application totaling \$182,400 to rehab 8 owner-occupied housing units; the Utilities Commission and local bank committed \$50,000 in leverage funds for this grant. The project moved forward to the full application process in 2015.

**Lanesboro/Mabel:** Grant was closed out on December 31, 2014. 5 commercial projects and 16 owner-occupied housing units were completed using \$449,000 in SCDP funds and \$126,848 in leverage funds totaling \$575,848.

**Spring Valley**: The SCDP grant is in its second year with a goal of 15 commercial and 14 rental housing units, utilizing a grant of \$539,750 of SCDP funds. \$77,000 from GMHF and EDA funds are being used for leverage funds.

**Red Wing HRA**: Awarded a grant in 2014 in the amount of \$683,184. The goal is to rehab 12 commercial projects and 10 owner-occupied housing units. The Red Wing HRA and Port Authority also committed \$316,810 in leverage funds.

**Wykoff:** Funds were utilized for a new wastewater treatment plant; \$500,000 from SCDP and \$2,469,000 from USDA, for a project total of \$2,969,000.
