#### A Note From Our CEO

In the investment world, the main measurement of success is a metric called return on investment, more commonly referred to as ROI. ROI is used to measure one investment against another so a determination can be made in regards to further/additional investments.

In the economic development world, ROI is less clear how to calculate. However, in 2017, it is very clear that CEDA had an outstanding ROI for those communities/counties/organizations that contracted with us and for those investors that believe in the mission. In taking a look at one aspect of our model – grant writing – in 2017 CEDA team members, with assistance from our contract holders, authored grants that were awarded for our region in the amount of \$5,896,549.

This is quite an accomplishment and CONGRATULATIONS to all involved! When you consider that the 2017 CEDA budget was \$1,250,000, to bring into the region four and a half times more than our budget is something to be very proud of. Over the past five years, CEDA team members have authored grants that have been awarded in the amount of \$15,187,384.50.

Again, this is quite an accomplishment!

Grant awards are a solid number that can be looked at when considering ROI. There are many other factors in economic development that aren't so easy to calculate but are very important to communities/counties and our region. They include: job creation and retention, tax base enhancement, business retention and expansion, revitalization of main street, infrastructure improvements and numerous quality of life issues. Pairing these factors with the grant awards, it is easy to see that 2017 was quite a successful year.

When we look at investing in our region, we look at many things as well – the CEDA Expanded Marketing Program continues with a full head of steam in doing external marketing by representing our region at local, state and national events; we continue to market internally by partnering for the Regional Development Tour; we continue to research and bring forth to our region "best practices" from partnerships that we have nurtured; starting a new program called the Micro-Community Program; providing assistance to new or expanding businesses; to continue to move forward with the Government Relations Program and to continue with each and every one of our contract holders and benefactors.

We also look to invest in our team members – the backbone of CEDA. Personnel is our largest but most important expense. We are strategically investing in our team members to be competitive in the marketplace and retain the strong team that we have so we can continue to keep growing the businesses and helping the communities that we are contracted with or will be contracting with in the future. If we want to stay strong, we need to invest in ourselves...and we will.

## 2017 Highlights

#### Blooming Prairie, MN

- Approved \$50,000 in financing, including \$10,000 forgivable, to Bunkies Grille & Lanes to rehabilitate an historic barn in downtown Blooming Prairie saving four jobs, preserving three historic properties, and leveraging \$30,000 in private equity investment.
- Awarded \$5,000 grant by Compeer Financial to complete architectural and market feasibility evaluations of a childcare center, gymnasium, and auditorium.
- Partnered with Omnibyte Technologies to betatest community-based social media platform, rTown.
- Completed over 60 business retention and expansion visits.

#### Chatfield, MN

- Awarded \$177,000 Business and Public Infrastructure (BDPI) grant from MN Department of Employment and Economic Development (DEED) and secured a 0%, \$300,000 loan from MiEnergy Cooperative to improve Industrial Drive, creating up to 14 new jobs.
- Completed \$5.53 million Phase I renovations of the Chatfield Center for the Arts; to complete building renovations, applied for \$7.985 million for Phase II.
- Facilitated \$25,000 loan to new business; filling and improving a vacant downtown storefront.
- Assisted with the implementation of a transportation partnership with SEMCAC to provide local and regional busing.
- Published a community visitor guide brochure for distribution throughout the region.

#### Claremont, MN

- Managed completion of 5th Street construction improvements including \$500,000 BDPI award, \$590,000 Steele-Waseca Cooperative Electric REDLG bond, and \$1.85 million TIF district.
- Co-hosted Commissioners' tour of Al-Corn Clean Fuel expansion, which created 12 FTE jobs, invested \$146 million in modernization and expansion, and is projected to increase city tax base by 135%.
- Partnered with Rochester Area Habitat for Humanity, Citizens State Bank of Hayfield, and USDA Rural Development to create new rural single family housing construction program. First two homes using this program have been scheduled for construction Spring 2018.

- Lent \$25,000 to French's Repair and Fabrication, Inc. to expand existing location, leveraging \$208,000 in private investment, and creating 2 FTE jobs.
- Implemented Property Assessed Clean Energy and financed \$116,000 in energy efficiency improvements through the new program.

- Hosted CEDA's Regional Bus Tour, and Marketing in the Morning, and presented the Eyota Market Area Profile, a study that details Eyota's retail activity and shopping habits.
- A special committee was created to work with Tealwood staff to enhance Arbor Gardens Senior Living Center. Year one resulted in many building improvements included a wide variety of improvements.

#### Fillmore County, MN

- Welcomed a new team member with ample talents and experience to provide exemplary service and move through multiple projects.
- Reviewed, amended and modernized By-laws and Enabling Resolution.
- Began partnership with St. Mary's University of Winona to create a new public facing web-map promoting outdoor recreation opportunities in the County.
- Awarded \$75,000 to Acentek to begin Fiber to the Home Broadband Upgrades in the City of Lanesboro.

- Hosted the Annual Summit focusing on downtown revitalization.
- Hosted a Housing Summit outlining available programs and resources.
- Worked with prospects on multiple projects.

- Facilitated planning (187 days) and implementation of RAGBRAI XLV. Over 30,000 riders and support personnel stayed overnight in Cresco, July 27th after passing through Protivin with riders from every state and 30 countries.
- Worked with local Veterans to raise over \$150,000 to develop a Howard County Memorial Park featuring the Freedom Rock in Cresco.
- 2017 saw over \$43,000 in Cresco Chamber Dollars purchased promoting the shop local theme.

- Currently working with local business and the USDA on REAP grant and loan funding for new screen printing machine and energy efficiency improvements.
- Working with Buxton Analytics to collect data and assist with disseminating information to businesses in the community. The program also assists with messaging and consumer outreach.

#### Lake City, MN

- Received Southern MN Initiative Foundation (SMIF) Grants for the multi-year Rural Entrepreneurial Venture program as well as to participate in the Making It Home community identity development program.
- Partnered with Tourism Bureau to launch rTown smartphone app and printed itineraries to inform visitors on what's available to do in Lake City.
- Partnered with Southeast Minnesota Multi County HRA to submit a preliminary Small Cities Development Program grant application to DEED.
- Supported Friends of American Ski Jumping in efforts to bring an Olympic Ski Jump to Frontenac, opening 2019.
- Worked closely with Lake City Sanctuary Hospice developer as they bring a state-of-the-art hospice facility to Lake City and surrounding communities, also opening 2019.

#### LeRoy, MN

- Expanded LeRoy City Lines from one bus to three in less than one year, connects LeRoy, Grand Meadow and Chester, IA with Rochester, twice each in the morning and afternoon. Also expanded charter services.
- Participated in the Fall 2017 Transportation Summit at NE Iowa Community College to discuss LeRoy City Lines. The seminar was sponsored by Iowa's Upper Exploreland Regional Planning Commission.
- Continued work on 15,000 sq. ft. EDA-owned commercial building on Main St/Hwy 56, including demolition of substandard portions of the building. Worked with two prospective buyers.

#### Lewiston, MN

- Hosted 50 individuals for the Regional Development Tour in June 2017.
- Worked with Widseth Smith Nolting for city housing study. The study will be completed by around June of 2018.
- EDA Approved \$1,800 land survey to assist local Girl Scout in her pursuit of her Gold Star project, which is to create a dog park in the city.

#### Mabel, MN

- Continued efforts to construct an incubator building to be owned by the EDA and leased to a local daycare provider for expansion of her daycare business.
- Working with a local business person for possible construction of a new building to house a hair salon, photography studio, and fitness center.

- Finalized year one of a two year SCDP grant project to improve eight blocks around town square, including loans to assist with the private financing portion.
- Recommended the sale of four of the City's residential parcels for the future development of six new townhomes near the Preston State Trailhead.
- Created and oversaw Preston's "Spare Change" Grant program, presented grants to three community organizations.
- Sponsored both a needs study and an economic impact study, which were presented to the State Legislature, moving the Fillmore County Veterans Home Bill through State Legislature to the Governor's desk.
- Participated with the University of WI to update the Driftless Area Angling Economic Impact Study, organized and lead a Regional Summit on the subject.

#### Rushford, MN

- Secured funding of \$9,800 for two kiosks to increase downtown growth.
- Assisted funding of four Micro Grants to businesses in the city.
- Restructured the Forbearance Policy to include loan modification.
- Made business outreaches on 236 occasions.
- Revised Micro Grant to include Performing Arts, and created a contact list.

#### People's Energy Cooperative

- Provided \$75,000 in startup financing to the forthcoming Little Eagles Child Care Center in Eyota, MN. The \$1,033,850 project will provide 96 childcare slots and create 13 jobs.
- Provided \$100,000 in expansion financing to Podein's Power Equipment in Stewartville, MN, leveraging a total \$480,000 investment for a showroom building expansion and retaining 8 jobs.
- Granted \$108,843 to community organizations through Operation Roundup, and \$3,395 to service territory communities for regional economic development projects.
- Hosted 60 economic development professionals for a workshop on the economic benefits of local foods, providing education and resources for the region's growing industry.

- Began a new program that provides cash incentives per job created in the purchase of an existing structure within the City of Stewartville.
- Provided gap financing of \$50,000 for building improvements at a long-time community business' Main Street location.
- Approved a \$50,000 loan for the construction of a new, 99 child capacity childcare center.

## Special Projects

#### Economic Impact Study

Received a **\$275,000** legislative appropriation in partnership with the Southeastern Minnesota League of Municipalities to engage a firm to conduct an economic impact study of the projected growth in southeastern Minnesota and the effect the growth will have on municipal infrastructure.



#### Emerging Entrepreneur Loan Program

Approved **\$60,000** Emerging Entrepreneur Loan Program loan to Early Advantage Developmental Childcare Center to gap finance a \$3.1 million expansion adding 61 childcare slots in Byron, MN.

#### Farmable Public Land Inventory

The Potentially Farmable Public Land Inventory has added new parcel data through the Department of Revenue's PRISM dataset and continues to be made publicly and freely accessible with CEDA as owner and host of the resource.



#### **Broadband Access**



AcenTek, partnered with CEDA, received a \$2,011,628 grant from the Minnesota Department of Employment and Economic Development (DEED) to extend fiber broadband access to 557 unserved and underserved homes and businesses in the Rushford Village and the rural Rushford area in Fillmore County.

#### Small Business Counseling

As a partner of the **Small Business Development Center**, CEDA team members provide free, confidential, one-on-one counseling for current and aspiring business owners. Services provided by CEDA team members include business planning, financial packaging, market research, budgeting, succession planning and more.

In 2017, CEDA worked with 26 businesses for 309 hours of personalized small-business assistance.

## Expanded Marketing Program

CEDA's Expanded Marketing Program began in 2016, and has been an effective means of actively promoting our communities to outside areas and organizations as well as drawing in regional partners to experience the numerous opportunities present in those communities. Here are a few highlights:

- CEDA attended several **international trade shows** such as: BIO, PACK, IPPE and Medical Design and Manufacturing.
- Valuable **Best Practice Visits** were conducted in Sioux Falls, SD and Fort Collins/Boulder, CO.
- The second annual Regional Development Tour hosted 50 professionals on a mobile event featuring 4 Minnesota communities: Chatfield, Lewiston, St. Charles, and Eyota.
- Hosted 4 Marketing in the Morning quarterly business breakfasts, including a Global Entrepreneurship Week endorsed event, to educate small business professionals and community leaders.
- Attended the MAEDC Site Selector Conference in Chicago, gaining access to a current database of over 2,000 national site selectors.
- Kicked off the Government Relations initiative to increase communication with elected officials in local, state, and federal positions. CEDA staff engaged with legislators at their state capitals as well as in Washington D.C.

## Small Cities Development Program

CEDA continues to work with Minnesota's Department of Employment and Economic Development to administer the Small Cities Development Program. This program distributes federal block grant dollars to communities with fewer than 50,000 residents. Qualifying cities and counties can utilize funding for housing, public infrastructure and commercial rehabilitation projects. Altogether, the program includes nearly \$7 million in federal, state, and local matching dollars.

Dodge Center received clearance to begin the owner occupied Small Cities Development Program. The goal is to provide funding to renovate 17 low to moderate income homes. There are currently 10 applications in process in the first three months of the three year grant. This grant is funded by both the City of Dodge Center through Program Income and the Minnesota Department of Employment and Economic Development.

Eyota will move forward with the full SCDP application. The city is requesting funding for rental properties in the city. There is potential funding for 28 rental units in Eyota. Notice of grant awards will be announced late in the summer.

Caledonia will move forward with the full SCDP application. The City is requesting funding for rental, commercial, mixed use and owner occupied properties in the city. CEDA is partnering with SEMCAC on this large application Notice of grant awards will be announced late in the summer. Red Wing had three commercial rehab projects administered using \$214,597 from the Red Wing HRA Program Income fund and leverage funds from the Port Authority.

LeRoy is in the second year of their SCDP grant. CEDA staff is administering (7) commercial rehab projects, using \$168,000 SCDP grant funds and leveraging \$21,000 of LeRoy EDA revolving loan funds.

Preston is in the second year of their SCDP grant which is being used to rehab (12) commercial projects using \$288,000 of grant funds and (22) rental units using \$252,000 of grant funds. Also, \$68,500 of Greater MN Housing Funds and \$51,500 of EDA revolving loan funds were used to assist with the private financing portion of these projects.

Houston was awarded \$580,000 of SCDP grant funds to construct a new Radium Treatment Plant, to be constructed in the Spring of 2018.

Harmony closed out their SCDP grant in December 2017, rehabbing (8) owner occupied housing units using \$182,400 SCDP grant dollars and leveraging \$25,000 from Harmony Utilities. Elgin submitted a CEDA authored preliminary proposal and a full application requesting \$379,500 SCDP funds and leveraging \$37,500 in matching funds to rehab (15) owner-occupied housing units for low-to-moderate income households.
