- The Workforce Development Department, in collaboration with South Central Service Cooperative, expanded into one new school district, creating more opportunities for local employers to engage with students and generate a talent pipeline to combat workforce shortages. We will begin working with several more school districts in the upcoming year, continuing to expand this department and its impact.
- The Planning Department was re-structured and expanded, bringing on a new two-person team working to provide housing studies, comprehensive plans, land use plans, strategic planning sessions and more to our rural communities.

In addition to our wonderful board and team members that are able to execute this work, I would also like to take this opportunity to thank the CEDA investors and partners who believe in our mission and continue to support us. Your trust and belief in our organization is greatly appreciated! 2022 COMMUNITY HIGHLIGHTS

Community Highlights are bullet points submitted by team members from every CEDA community, featuring three projects that our team helped facilitate over the course of the year. These projects demonstrate the impact CEDA has in our rural communities. Read on to learn more about what we accomplished in 2022!

BENSON, MN POP. 3,480

- Authored and was awarded a total of \$32,000 in grants from Swift County ARP, Benson Community Foundation, Galen Hanson Foundation and Sonsteng Foundation to add two new water features to the Benson Family Aquatic Center.
- Conducted a feasibility study examining the purchase of a 127-acre piece of land for the location of a new industrial park.
- Established a strong social media presence that filled an existing gap in communication between the community and city leadership.

BLUE EARTH, MN POP. 3,174

- Administered three \$25,000 forgivable loans to business owners purchasing existing businesses.
- Authored and was awarded a \$20,000 Blandin Foundation Rural Leadership Boost Grant and a \$10,000 SMIF Grant to continue supporting and developing welcoming initiatives.
- Initiated a collaboration with the Minnesota State University, Mankato Task Force to better connect international students with workforce opportunities in rural Minnesota.

CANNON FALLS, MN POP. 4,220

- Executed the sale of an EDA-owned property and development agreement for the construction of a 79-unit market rateapartment complex.
- Acquired a blighted property from the county and demolished the existing structures to prepare the site for development; sold the newly developable property to the local housing initiative for the construction of a single-family home.
- Purchased a 40-acre piece of developable land near the school campus to build new housing options for the community.

SPECIAL PROJECT HIGHLIGHTS

Emerging Entrepreneur Loan

CEDA authored and was awarded a \$100,000 DEED Grant in 2021 that allows staff to provide loans to startup or existing businesses that have been operational for two years or less in rural communities. The goal of this program is to foster employment and business growth in rural Minnesota. The first program loan was administered to the DeMarce Theater in Benson, MN for \$50,000 to remodel the facility.

Planning Department

CEDA expanded the Planning Department, hiring a full-time Director of Planning and Planning Specialist. Under new leadership, formal processes were implemented for the procurement, development and completion of Comprehensive and Strategic Plans, Housing Studies and Community Surveys.

Marketing Intelligence Dashboard

CEDA utilized their customer analytics software to complete 14 Market Potential Analysis, Community Profiles and Feasibility Studies across a variety of industries, including healthcare, childcare and food service. These analyses can be leveraged to attract and justify new business ideas and development, growing the economic vitality of the rural communities we contract with.

Spring Grove Community Real Estate Fund

CEDA worked with REVocity and local investors in Spring Grove, MN, to facilitate the creation of a locallygoverned real estate fund. The fund raised over \$600,000 for community impact investment projects in 2022, including the purchase and renovation of three historic Main Street buildings and plans for a new housing development on blighted city property.

Small Business Trainings

CEDA partnered with Southern Minnesota Initiative Foundation (SMIF) to organize, market and host small business trainings to provide marketing and business development tools on topics such as bookkeeping, food licensing, website development and digital marketing. Overall, 13 trainings were provided to 82 attendees.

Rural Entrepreneurial Venture (REV)

CEDA staff helped facilitate the REV program in four communities: Blue Earth, Spring Valley, Lanesboro and Mapleton. In Blue Earth, the REV program helped the community launch a Welcome Basket program for new residents and supported additional welcoming initiatives through a \$30,000 grant. In Spring Valley, the REV program led to the creation of a local business alliance who planned weekly summer downtown block parties featuring local retailers, food and beverage vendors and activities. In Lanesboro, the REV program led to the creation of the Lanesboro Entrepreneur Network, a committee who provides tools and resources to new and existing businesses, promotes tourism and assists with housing development. In Mapleton, the REV program led to the creation of a business roundtable program to engage the business community, and expanded community marketing efforts with the design of a new city logo and website.

WORKFORCE DEVELOPMENT HIGHLIGHTS

Authored and was awarded a \$40,000 Future Ready CTE! Grant for Blue Earth Area (BEA) Schools for the creation of a drone academy, and authored and was awarded a \$40,000 Future Ready CTE! Grant for United South Central (USC) Schools for the installation of a coffee shop on the school campus.

Worked with BEA and USC School Districts to create a community retention program where students are given career exploration tours to highlight job opportunities within the region with the intention of encouraging students to return to the area after graduation. One of these tours resulted in a job opportunity for one student post-high school. Additionally, worked with local employers to create new job opportunities for high-school aged students in their facilities with the option to turn into a full-time position after graduation.

Worked with Lake Crystal Wellcome Memorial (LCWM) Schools to coordinate financial literacy and employable skills seminars for senior students, plan and host a job fair featuring local employers, partner with local businesses to update the Career Wheel, and plan manufacturing tours for classes of students.

GRANTS DEPARTMENT HIGHLIGHTS

Authored and was awarded a \$250,000 USDA Value-Added Producer Grant for Cannon River Winery in Cannon Falls, MN which will be used to expand their market.

Administered Minnesota Community Development Block Grant - Coronavirus (CDBG-CV) for Cevlon. MN to bring fiber internet to the home of residents (\$983,105 grant); Benson, MN to retrofit the Armory into an emergency shelter (\$678,000 grant); Faribault County, MN for the installation of fiber internet in the communities of Bricelyn, Delavan, Elmore and Frost (\$2,886,206 grant); and Wabasha, MN to assist nine businesses with HVAC replacement through the City of Wabasha HVAC Improvement Grant (\$107,350 grant).

Authored applications for the USDA Rural Energy for America Program (REAP) to assist farmers in southeast Minnesota in the acquisition of solar panels on their farms. These solar panels will allow them to generate their own energy, and will set them up for a more sustainable future.

Presented information on the grant writing process at the League of Minnesota Cities Fall Forum. In this presentation, the steps a community should take to prepare for a grant were highlighted and the collaborative process between CEDA's Grants Department and clients was outlined.

CEDA SMALL CITIES DEVELOPMENT PROGRAM HIGHLIGHTS

CEDA continues to work with Minnesota's Department of Employment and Economic Development to administer the Small Cities Development Program. This program distributes federal block grant dollars to communities with fewer than 50,000 residents. Qualifying cities and counties can utilize funding for housing, public infrastructure and commercial rehabilitation projects. Altogether, the program includes nearly \$7 million in federal, state, and local matching dollars.

BLUE EARTH

Blue Earth was awarded a \$317,400 grant for the rehabilitation of 12 owner-occupied homes. Grants began disbursement in 2022, with the completion of two projects and an additional five projects going out for bid. CEDA is administering all funds.

HAYFIELD

Hayfield was awarded a \$581,900 grant for the rehabilitation of owner-occupied homes. The grant closed out in 2022, with the completion of 23 projects. CEDA administered all funds.

CALEDONIA

Caledonia was awarded a \$824,698 grant for the rehabilitation of owner-occupied housing, rental housing and commercial properties. The grant closed out in 2022, with the completion of 10 commercial projects and 14 rental projects. CEDA administered the commercial, mixed-use rental and multifamily rental portion of the grant and Semcac administered the owner-occupied portion of the grant.

HOKAH

Hokah was awarded a \$721,625 grant for the rehabilitation of owner-occupied housing, rental housing and commercial properties. Grants began disbursement in 2022, with two rental projects and two commercial projects beginning construction, and several more projects going out for bid. CEDA administered all funds.

HARMONY

Harmony was awarded a \$1,017,750.00 grant for the rehabilitation of owner-occupied homes and commercial properties. Funds will begin disbursement in 2023. CEDA will partner with Semcac to administer the funds.

RED WING HRA

The Red Wing HRA was awarded a grant for the rehabilitation of housing and commercial properties. Grants were being disbursed in 2022, with the completion of one commercial project and two additional commercial projects going out for bid. CEDA partners with the HRA in administering the funds.
